

# Website Privacy Policy

TradeNext (hereafter referred to as TradeNext, we, us, our), composed of Explore Global Limited and Progressium LLC operates <a href="https://www.tradenext.com">www.tradenext.com</a>. Information regarding the aforementioned entities can be found on our Website.

It is TradeNext's policy to respect your privacy regarding any information we may collect while operating our website.

#### 1. Website Visitors

Like most website operators, TradeNext collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. TradeNext's purpose in collecting non-personally identifying information is to better understand how TradeNext's visitors use its website. From time to time, TradeNext may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

TradeNext also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on titanfx.com blogs/sites. TradeNext only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog/site where the comment was left.

# 2. Gathering of Personally-Identifying Information

Certain visitors to TradeNext website choose to interact with TradeNext in ways that require TradeNext to gather personally-identifying information. The amount and type of information that TradeNext gathers depends on the nature of the interaction. For example, we ask visitors who sign up at titanfx.com to provide a username and email address. Those who



engage in transactions with TradeNext are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, TradeNext collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with TradeNext. TradeNext does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

### 3. Aggregated Statistics

TradeNext may collect statistics about the behavior of visitors to its websites. TradeNext may display this information publicly or provide it to others. However, TradeNext does not disclose personally-identifying information other than as described below.

# 4. Protection of Certain Personally-Identifying Information

TradeNext discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on TradeNext's behalf or to provide services available at TradeNext website, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using TradeNext website, you consent to the transfer of such information to them. TradeNext will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, TradeNext discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when TradeNext believes in good faith that disclosure is reasonably necessary to protect the property or rights of TradeNext,



third parties or the public at large. If you are a registered user of an TradeNext website and have supplied your email address, TradeNext may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with TradeNext and our products. If you send us a request (for example via email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. TradeNext takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

#### 5. Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. TradeNext uses cookies to help TradeNext identify and track visitors, their usage of TradeNext website, and their website access preferences. TradeNext visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using TradeNext website, with the drawback that certain features of TradeNext website may not function properly without the aid of cookies.

#### 6. Business Transfers

If TradeNext, or substantially all of its assets, were acquired, or in the unlikely event that TradeNext goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of TradeNext may continue to use your personal information as set forth in this policy.
