

TERMS AND CONDITIONS:

This promotion is provided by Explore Global Limited and Progressium LLC, trading under TradeNext, to its clients. By participating in this promotion, the clients hereby acknowledge, confirm and accept to be bound by the following terms and by TradeNext's Terms and Conditions.

Promotion overview

TradeNext Diwali Bumper Offer is open to all registered and verified clients of TradeNext who have met the Criteria for this lottery as set out in this Terms and Conditions document to win a prize during the lottery period from October 24rd 00:00 GMT+3 to November 14th 23:59 GMT+3 (End date).

1. Specific Offer terms

- 1.1. During the Offer, clients have the opportunity to receive Tickets by satisfying requirements laid out below and win prizes if their tickets are randomly selected to win.
- 1.2. A client receives his first participating Ticket for the offer once they have made a **deposit of at least 200 USD** and **traded at least 2 lots** (all asset classes and instruments are eligible).
